Item No. 1 To discuss International partnership with Arizona State University for starting of dual degree programs: (i) BS in Computer Science and (ii) BS in Business Data Analytics

Dr. Rajeev Kumar Singh presented before the Academic Council the proposal to have an International partnership with Arizona State University (ASU) for starting of dual degree programs. He briefed about the importance of the internationalization of Shiv Nadar IoE to achieve top global ranking, keeping in mind the UGC's revised mandate that allows the offering of a dual degree and other kinds of programs with foreign partners. He further explained that the programs are 2 + 2 dual degree programs, and the students will get two degrees, one from Shiv Nadar IoE and the other from ASU. Students will study at Shiv Nadar IoE for two years and then join ASU for the next two years. The partnership will enhance the opportunity for students to gain more experience globally, get a chance to study from a pool of international faculty and learn a variety of courses not offered in Shiv Nadar IoE. It will also give opportunities for faculty development, curriculum, and enhanced student's experience.

He further stated that over the past few years, many students have attended US universities and institutions for undergraduate studies, especially in Computer Science and Business Data Analytics. Hence, Shiv Nadar IoE can leverage the opportunity of such programs with US universities and students can benefit from cost-effective education. The advantage of these programs is that they are STEM programs and students will get Optional Practical Training (OPT) for around three years and access to global career Services.

He also explained the ranking and other characteristics of ASU. The Vice Chancellor, in between, said that ASU is a public university and is less expensive than other private universities.

Dr. Rajeev Kumar Singh further explained the features of two undergraduate programs to be partnered with ASU i.e. (i) BS Computer Sciences (ii) BS Data Analytics, its overview, credit distribution, credit transfer process, modality, loan availability, aim, accreditation, work permit, career opportunity etc.

The members have appreciated the effort made by the Vice Chancellor and opined that these partnerships with internationally acclaimed universities will benefit Shiv Nadar IoE to improve its ranking and accreditation nationally and globally. After a detailed discussion, the AC recommended the above-mentioned programs for implementation.
